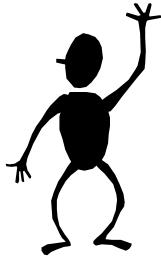

DOT SAP Course: We have received very positive feedback from our affiliates who have completed the SAP self-study manual and SAP test offered through EHP. Many affiliates especially enjoyed the convenience of a take-home test. If you are planning to provide services as a Substance Abuse Professional (SAP) after 12/31/03, you must be in compliance with the DOT requirements. EHP SAPs are eligible for a discounted rate on the SAP manual and test, if they are purchased through EHP. When purchased directly through NAADAC the price is \$275. The price for EHP affiliates is \$180. If interested, send payment to EHP at P. O. Box 1670, Bethesda, MD 20817 (check or money order should be made out to NAADAC).
